## 2.6 Public Comment

Bonnie Glotz	Ms. Glotz stated she has no problem with students wearing masks on the bus, but thinks they should be able to take them off when they are at their desks.	
Bridget Schwab	Ms. Schwab stated she is in full support of choice. She prefers to have a choice.	
Fern	She stated she is in favor of the mask mandate and thinks it should be followed. Masks work and do not reduce airflow. She has panic attacks and can wear a mask.	
Lacey Becker	Ms. Becker does not think someone with a medical condition should wear a mask. It has been too hot and the ventilation is not great. People have been out and about all summer with no masks, and it should be up to the parents to decide if their child wears a mask. Her son will not be wearing a mask because of a medical condition.	
Jewel Rozanski	Ms. Rozanski believes the majority of parents are in favor of choice no matter what the choice is and parents are tired of being robbed of making that choice. They also understand that this is of no fault of the Board and Administration.	
Catrina	She stated she is in support of the mask mandate, because she has already lost a child to COVID, and she strongly stated that sending a child to school in a mask is much more preferable than choosing a casket for your child. Urged the District to follow the mandate.	
Jessica	She thanked the Board for what they do and stated that she and her daughter have panic attacks when wearing a mask. Her daughter did the hybrid learning system, and it did not go well. Her grades suffered and she was depressed. She believes this is government overreach.	
Jason	He stated he is completely against the mask mandate, and it is government overreach. He offered information on studies that show any mask that is not an N95 mask will not protect from the risk of getting COVID. He offered condolences to the woman who lost her child, but studies show only 2 out of 1 million children will die of COVID, and it is ridiculous to put masks on children.	
Hobart	He does not agree with the mask mandate. It is not healthy and a piece of cloth will not prevent catching a virus or cold. Governor Wolfe overstepped his bounds, and it is time to take a stand. It is parents' choice, and his children will not be wearing masks.	

### 3. New Business

3.1 ARP ESSER Health & Safety Plan - Amended

<u>MOTION</u>: That the Board of School Directors immediately comply with the Governor's and DOH mandate of August 31, 2021...

Motion by Arthur Stewart and second by Marcy Morgan

Arthur's phone cut out, and it was not clear if he stated his entire motion.

Some questioned if it was the full motion and wanted clarification before a vote was taken.

Arthur Stewart reconnected and tried to state his motion again and the call again dropped.

Arthur Stewart reconnected and stated his complete motion as follows:

MOTION: That the Warren County School District (WCSD) immediately comply with the August 31, 2021 "Order of the Acting Secretary of the Pennsylvania Department of Health Directing Face Coverings in School Entities" by requiring face coverings to be worn at all WCSD facilities subject to the exceptions permitted in the Order. In the event a student, staff member, visitor or other person appears upon WCSD premises without a face covering, and in the event that no exception to the Order is readily apparent (example of readily apparent exception: participant in sports activity), the person will be given one reminder of the Order requiring face coverings. In the event the person fails to then don a face covering the WCSD will assume the face covering will either cause a medical condition, or exacerbate an existing one, including respiratory issues that impede breathing, a mental health condition or a disability.

Motion by Arthur Stewart and seconded by Jeffrey Labesky

<u>AMENDMENT TO MOTION</u>: It was moved by Mr. Stewart and agreed to by Mr. Labesky to add "that any person that is asserting an inability to wear a face covering because of a medical or mental condition is not required to provide a doctor's or other's proof.

### Call the Question

<u>MOTION</u>: It was moved by Arthur Stewart to Call the Question and seconded by Jeffrey Labesky that the Board of School Directors act on the APR ESSER Health & Safety Plan as amended by Arthur Stewart's motion.

Calling the Question failed and Board discussion continued. Following discussion the motion as made by Arthur Stewart and the agreed upon amendment by Jeffrey Labesky was acted upon.

ARP ESSER Health & Safety Plan (as originally presented) Failed 3-5-0 <u>MOTION</u>: That the Board of School Directors approves the revised ARP ESSER Health and Safety Plan, as presented.

Not Present at Vote: Arthur Stewart (Mr. Stewart left the meeting prior to the vote at approximately 9:05 a.m.)

Mr. Byham stated that whether the Board of Directors amends its Health & Safety plan or not, the mandate usurps the plan, and the District must follow the mandate. The Order goes into effect on September 7<sup>th</sup> regardless.

Mrs. Stewart stated that students coming to school without a mask will not be admitted to a classroom. There is an exemption process that was used all last year and will be used again.

Mrs. Huffman stated we are faced with very difficult decisions and financial implications. As she has watch the Zoom chat she sees that we are dividing ourselves as united front and community. She asked everyone to be supportive and patient and do what you feel is best for your loved ones. Please be kind, and please be respectful. This is an extremely hard position that not just the school board members but we as citizens of the United States and even what is going on in the world. We are doing our very best, and she hopes parents would teach their children about all the things going on and to be very supportive. She agrees with the arguments put forth today, but please remember we need to stand together and try to find the best way to move forward through this pandemic.

Mrs. Stewart stated that in her position she is obligated to enforce the order and commented that the Governor was very clear in his announcement of the new mandate that he is ready to shut down schools that do not comply with the order. Mrs. Stewart also stated that the administration and Board have worked 198 percent this past year to keep the doors open for students and will do everything in their power to again make sure schools are open this year and that is what we will fight for.

#### 3.2 Other

Mrs. Zariczny announced an executive session was held prior to this meeting to receive information from the solicitor.

Mrs. Zariczny thanked those who attended and participated in the meeting, stating she appreciated the discourse and hearing the different points of view without name calling or animosity. Without consensus by the Board on a motion, the mandate will still go into effect as stated by the Solicitor. If anyone has question, please reach out to the Office of Pupil
