Mrs. Zariczny announced the Board held executive sessions on Monday, October 4, 2021 and Wednesday, October 6, 2021, to receive legal advice from its solicitors.

1.6 Public Comment

Bridget Schwab	Ms. Schwab stated children are going through many challenges because of COVID-19 and their education is being stripped from them. How many times will we do the same thing expecting different results before calling it insanity? With the Health and Safety Plan, this is the same thing that was done last year and are there any true successes? Our children have lost trust and a sense of security in their schools. The biggest loss of all is an immeasurable amount of education. She quoted the First Amendment of the Constitution. She sent informational links to all of the Board members showing adverse effects of wearing masks. She was disappointed that six of the Board members caved to the pressure of the mask mandate. She will give her students a fighting chance and take them out of the Warren County School District.
Jewel Rozanski	Mrs. Rozanski thanked the Board and stated the members have been courageous and did the job they were elected to do representing the constituents, and tried to get what 470 other school district did by not forcing student to be labeled with a diagnosis and to be able to breath unhindered. She took time to read the complaint and the judge's order and has many questions. She believes that no matter what side of the issue people are on, each could pose the exact same arguments for their beliefs. Had the District not given parents a choice, the arguments would be exactly the same. She would welcome both sides to sit down for a civil conversation. She asked for clarification on the statistics mentioned in the lawsuit and would like answers to end the debate once and for all. Ms. Rozanski stated she and everyone else wants this to end. She wants children to be able to play together, to be friends together, the community to come together, and she wants every single parent to be the village in which the children deserve to be properly raised.
Amanda Lindemuth	Ms. Lindemuth thanked the Board members for their service to the Warren County Community. She stated that each ESSER Plan should be tailored to the unique needs of each local education agency and schools must take into account public comment related to the development and revision of the plan and thanked the Board for that opportunity today. She asked that the WCSD not follow the PA Health Secretary's order as based on past rulings for the order, because it has not been legally enforceable. Secondly, if the school district feels they must follow the order, then she requests the District follow the order and not add to it. According to this order, exemptions are allowed for any teacher or child, student, staff, or visitor regardless of vaccination status that fits into any of the eight exemption categories. They are available on the PA Health Department website. In these categories, it does not require

	a doctor's exemption, or disability exemption. Requiring a signed doctor's note adds to the order. She asked the Board to take into account public comment from the past, as well as, today.
Gracie Gatto	Ms. Gatto stated she is a junior at Warren Area High School and she is frustrated with how masking and quarantining is affecting students' education. They are not learning as much as they should for many reasons. Teachers have to remind students to wear their masks properly; student debates on masking happen often; students have to sit in the auditorium and learn on their own when teachers are not available, and this happens daily. The fear of being quarantined causes her anxiety, and many of her friends feel the same way. The quarantine protocols are not the same for everyone. Students with medical exemptions from masks are criticized and questioned. Her education is very important to her, therefore she has started the enrollment process for PA Cyber school. She would like to return to Warren Area High School when education is the priority again. She asked that the Board make this happen soon.
