This grant in the amount of \$71,000.00 will provide funding to support the specific needs of homeless children and youth.

**Motion:** That the Board of School Directors instructs the administration to develop and submit an application to the Pennsylvania Department of Education ARP-HCY Homeless II grant to provide social work supports through the summer of 2024, as well as housing assistance and school supplies to identified students.

#### 3.9 GRANT: Cummins Grant Cycle 2022 (over \$5,000.00)

This is a grant that will be used to purchase equipment for the Warren County Career Center that will cost \$5,000.00 or more.

**Motion:** That the Board of School Directors instructs the administration to submit and application to the Cummins Grant Cycle 2022 for purchase of a desktop mill for use in the Warren County Career Center Machine Technology Program of Study.

BrainFuse is an online Tutoring Program available 24 hours a day, seven days a week to all Warren County School District Students. The usage report shows that students have been
