ARTICLE I: NAME

# **ARTICLE II: PURPOSE**

LEGACY is intended for the betterment of both student and faculty moral, as well as making our school a kinder and more inclusive place.

#### **ARTICLE III: MEMBERSHIP**

- A: Students of all grade levels are eligible to apply.

B: To become an officer, a student must be nominated and voted into office at the beginning of the school year.

# **ARTICLE VI: ELECTIONS**

A: All officer positions will be selected by the membership. Each term served will be the length of only one year. However, an officer may be elected to the same position more than once.
