<u>Finance</u>

- The Finance office is busy closing the fiscal year and reconciling over 260 individual budgets.
- We are busy processing all of the new hires and those that are leaving the IU for payroll.
- We are gearing up for the start of the school year and the salary increases for teachers, aides, Psych and interpreters.

School Improvement Services

- The Summer Food Service Program has ended services for the 2022 year. 34 sites participated this year serving 67,113 meals throughout Erie and Crawford Counties.
- The Migrant Education Program wrapped up their summer programs servicing over 300 students throughout the Erie, Adams, York, and Franklin Counties.
- The Adult Education Program was awarded a competitive grant through PDE worth \$922,020 to service Erie, Warren, Crawford, Venango, Forest, and Clarion Counties.
- All districts, charter schools, and shelters who requested back to school supplies for the 22-23 school year have been delivered for students who are experiencing Homelessness.

Special Education

- Our EI department has process over 100 referrals from July 1 to now.
- Open Houses are happening with all 11 of the Early Intervention classrooms this week.

State:

HB 2771 <u>BERNSTINE</u> - An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in school security, providing for school safety certification.

HB 2780 <u>NEILSON</u> - An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in certification of teachers, further providing for continuing professional development and for program of continuing professional education.

Ortitay Appointed to Basic Education Funding Commission— Speaker of the House Bryan Cutler (R-Lancaster) recently appointed Rep. Jason Ortitay (R-Washington/Allegheny) to be one of two representatives from the House Republican Caucus on the Basic Education Funding Commission. Created by Act 51 of 2014, the 15-member bipartisan commission developed and recommended to the General Assembly in 2015 a new formula for distributing state funding for basic education to Pennsylvania school districts. Every few years the commission is reconstituted to review the formula to make sure it is working properly and make recommendations for changes. I wanted to make sure you were aware of some important policy updates included in the <u>School Code</u> signed by Governor Wolf as part of this year's budget in addition to the \$1.8 billion increased funding to education.

There are dozens of provisions, but these are the ones (in no particular order) I thought might be of most immediate interest to you:

Dual Enrollment

School districts, charter schools, cyber charter schools, regional charter schools, and CTCs must have at least one dual enrollment agreement with a Pennsylvania postsecondary institution.

Educator Workforce

Establishes a Committee on Education Talent Recruitment within PDE to develop programs of study for high school students interested in pursuing careers in education, requires PDE to collect and annually post information on the educator pipeline, waives the Basic Skills assessment for three years, and provides pathways to Pennsylvania certification for out-of-state teachers, including career and technical education teachers.

Student Meals

All schools must assist students and families with applying for free/reduced-price lunches, and staff are prohibited from throwing out a meal after it has been served to a student – even if that student has an outstanding balance – in order to end the practice of "lunch shaming."

Industry Credentials

LEAs must include industry recognized credentials on student transcripts moving forward.

Graduation Requirements

Students in the class of 2023 can now meet the statewide graduation requirements through a two-test Keystone Exam composite pathway if they were impacted by the federal assessment waiver in 2020.

Keystone Diploma

Students who experienced educational instability during the 2021-22 school year may apply to PDE for a Keystone Diploma for the 2022-23 school year.

Continued Professional Education Requirements

Teachers, administrators, school professionals, and paraprofessionals have one additional year (until July 8, 2023) to complete their Act 45/48 continuing professional education requirements.

Services for Homeschooled Students

By the start of the 2023-24 school year, school districts must establish policies that allow homeschooled students to participate in courses, co-curricular activities, and career and technical education programs through the district.

School Safety

- LEAs must designate a school administrator to serve as a school safety coordinator with the Pennsylvania Commission on Crime & Delinquency (PCCD) and designated coordinators must complete training within one year of PCCD making the training available. Additionally, \$190 million in grants for new physical security and mental health initiatives are available, and applications for this funding are due to PCCD by August 31.
- Educator prep programs will be required to include at least 3 semester hours on trauma-informed approaches, suicide, bullying, and substance use awareness beginning July 2025.
- Lastly, all colleges, universities, and postsecondary private licensed schools must adopt a definition of consent as part of the school's code of conduct or sexual misconduct/harassment policy.

Student Financial Aid

Public colleges may no longer reduce a student's institutional financial aid unless that aid exceeds the cost of attendance or requirements related to athletics. In addition, the annual household income eligibility requirement for PHEAA's Ready to Succeed

Scholarship has been increased to \$126,000.

Dance Certification

A PreK-12 standalone Dance Certificate has been established.

Cambridge Advanced Exams

Cambridge Advanced Exams now count as an eligible type of credit for prior learning that transfers among colleges participating in the statewide college credit transfer system.

Federal

Lacking Bus Drivers, Schools Make Tough Calls on Transportation— Short on bus drivers, school districts around the country have revised transportation plans in ways that have widely impacted families' daily lives. In some districts, students who once rode to school will now have to walk. Others must board buses earlier so that drivers can complete two routes each morning. Office of Migrant Education News

The <u>Pennsylvania Migrant Education Program (PA-MEP)</u> strives to ensure that migratory children receive educational services aimed at developing students to their fullest potential. Since the 1960s, PA-MEP has been providing high-quality MEP-funded summer programs for children of migratory farmworkers. As part of their annual *Special Project Summer Programs*, the state will be hosting two-day regional camps for both middle and high school migratory students who are residing in their 27 counties. PA-MEP offers an interactive and customizable youth leadership and empowerment program designed for middle school migratory students and an interactive science, technology, engineering, arts, and math (STEAM) program designed for Pennsylvania high school migratory students.

The Northwest Tri-County Intermediate Unit (IU5), a PA-MEP subgrantee, provides supplemental educational services to migratory children, families, and out-of-school youth throughout 30 Pennsylvania counties. They offer on-campus programs across the western part of Pennsylvania and in-home lessons in all counties where migratory children reside. One such program is the Lake Erie Summer Program in Erie, Pennsylvania, a partnership between the IU5 MEP and the Erie Public Schools Refugee Program. IU5 hires Pennsylvania-certified teachers and teacher aides to provide learning opportunities in three areas: 1) reading, 2) math, and 3) science, technology, engineering, and math (STEM).

PA-MEP works throughout the year to design and develop summer programs that target the academic development of the migratory children they serve. These MEP-funded offerings supplement the education their migratory students receive during the regular school year by creating high-quality value-added content for their students, incorporating various teaching methodologies to engage and challenge migratory children and enrich their learning experiences.

Nationwide teacher shortage impacts Pennsylvania, local schools

As Pennsylvania students prepare to get back to the classroom, school districts across the commonwealth are facing a teacher shortage.
