Mrs. Stewart stated that it's not a one sentence answer. Title is a federal grant that has about a million and seven rules and regulations and staffing goes through a formula and ratio of staff to students. It's all about numbers. Mrs. Shultz explained that the four elementary schools are allotted a certain amount of money that is determined by their free and reduced lunch numbers. Money spent in each building is per pupil from low income families. When that number is considered then we place staff. By having the additional para at Youngsville, it put Youngsville out of rank order. WAEC has the highest number of low income children, then Sheffield, then Youngsville, then Eisenhower. We cannot spend more money per pupil at one building over another. The only way to make a dent in that configuration is to move staff. Dr. Mead manages the vast majority of the paras, and that number is going to vary depending on the disabilities of children where the programs are. We have paras that work with health needs, so they are staffed where those needs are.

Another question from Mrs. Sullivan is regarding the administrator changes. As a parent, keep in mind that these kids get use to these administrators and get close with them and feel comfortable. In the future please keep that in mind.
