1. Meeting Opening:

The Board meeting of the Northwest Tri-County Intermediate Unit Board was called to order by Dr. Andrew Pushchak, President, at 5:45 p.m.

Dr. Pushchak welcomed new Board Member, Mrs. Amanda Cox from Corry Area School District.

- C. Moment of Silence: Dr. Pushchak asked those in attendance to stand for a moment of silence.
- D. Pledge to the Flag: Dr. Pushchak led everyone present in the Pledge to the Flag.

- F. Recognition of Visitors: Dr. Pushchak welcomed all visitors in attendance.

2. Presentation of the Annie Sullivan Award:

Mr. Brad Whitman gave a brief overview of the Annie Sullivan award. "The award, named after Helen Keller's teacher and friend, is presented by each participating Intermediate Unit to an IU employee who facilitates acceptance of students with disabilities in schools and the community.

Mr. Whitman recognized Mr. John Kitcho, the 2022-23 Annie Sullivan Award recipient.

3. Reports:

A. Executive Director (Mr. Brad Whitman):

IU5

- We once again held our Summer Academy for Everyone (SAFE) program. We have had about 55 kids in attendance each day, representing three of our districts.
- As we start to get ready for the new school year, many of our staff have been working with the districts during their in-service days on such
 professional development topics as: Text Dependent Analysis (TDAs), Integration of a Multi-Tiered Systems of Support framework, structured
 literacy, among others.
- We hosted the I Love You Guys professional development program. During this training, individuals learned about the nationally recognized standard response protocol in a crisis situation as well as the standard reunification method. We had approximately 45 participants, representing several local districts, non-public schools, charter schools, as well as other IUs.
- Mark Perna, a national speaker on how we as educators can unleash the passion, purpose, and performance in younger generations and how
 that intersects education, careers, and workforce development come to our region this summer. Approximately 110 educators and
 administrators from the area were in attendance.
- We hosted a threat assessment team process training here at the IU on August 18th. The entire Erie admin staff and others attended to give us a total participation of 112 individuals from that district alone! We had an additional training in the afternoon for all other districts. 17 individuals, some from as far away as Punxsutawney, attended the afternoon session.
- August in-service week provided 15 different professional development sessions for the various staff members within the special education department.
- The Summer Food Service Program served a total of 43,800 meals across our tri-county area from June 12th through August 18th.
- TRiO's Talent Search program met 100% of their enrollment goal of recruiting 538 students for the 2022-23 school year. This milestone will provide experience points for the next time we submit a proposal for the next 5-year cycle of the grant.
- The state's allocation for the Act 89 Program was recently increased resulting in over 2,300 additional hours of service for our nonpublic schools.
- Over 60 paraprofessionals attended the 1st annual IU5 Paraprofessional Summer Academy this week. They participated in 6 sessions obtaining 18 out of the 20 required para hours for the school year.

State

The Senate returned to Harrisburg and the state budget bill was signed and sent to Governor Shapiro who signed <u>House Bill 611</u> into law the same day. The Governor line-itemed funding for the Senate approved PASS voucher program.

Most of the state budget is done. There are a few significant line items remaining that will need implementing language in the School Code or the Fiscal Code which are not done.

<u>Budget Secretary Uri Monson's communication to the General Assembly</u> itemized ten programs that will need additional instructions, including the following education programs:

- Level Up Supplement
- Teacher Stipends
- Environmental School Facilities
- Any Increase in the Educational Improvement Tax Credit

When and how these programs will be authorized in law is unknown. While most of the budget drama is over, there is more to come surrounding these programs. What to Know about the State Budget:

- On August 3, the state budget impasse ended as Governor Shapiro signed a \$45.5 billion budget (House Bill 611) into law.
- The adopted budget increases BEF by approximately \$567 million.
- The first BEF payments are being released at the end of August, as per the usual schedule.
- Approximately \$1.1 billion of the General Appropriations Budget requires code implementation language (fiscal code), therefore is on hold.
- The adopted budget increases Special Education Funding (SEF) by \$50 million, which is \$50 million less than what was proposed by the governor (\$100 million). The July SEF payments were released on Friday, August 11.
- The adopted budget increased Ready-to-Learn Block Grant funding by \$7.5 million. Ready-to-Learn payments will be the same dollar amount as received last year. The July Ready-to-Learn payments were released on August 11.
- The adopted budget increased Career and Technical Education funding by \$14 million. CTC payments will be released on schedule in August. While funds will flow, additional work is needed to implement the increased subsidy.
- Governor Shapiro's initiative for schools participating in the SchoolBreakfast Program provides for free breakfasts for all students during the 2023-2024 school year. Additionally, students identified as eligible for reduced-price lunches through the National School Lunch Program (NSLP) will not be charged for their meals.

Without a Fiscal Code, the Governor stated that \$1.1 billion of the spending plan would sit untouched at this time. This includes:

- \$100 million for school mental health grants
- \$100 million in Level Up funds
- \$10 million in teacher stipends
- \$125 million for school environmental repair grants
- \$50 million for school safety and security grant transfers to PCCD

We are currently unsure if there will be a fiscal code or school code for this budget, as there is a lack of consensus on many of these programs. The result of not having a fiscal code to allocate these funds is that the money allocated for each program would stay, undesignated, in the state's coffers and some of it would move to the Rainy-Day Fund.

Lawmaker Proposes Giving School Boards Authority To Cut Property Taxes By Hiking Other Taxes— A state lawmaker is proposing legislation that would allow school districts to decide whether to use other forms of tax to replace a portion of the revenue they generate with property tax. Gov. Josh Shapiro signed legislation expanding property tax rebates for seniors and those with disabilities earlier this month. Efforts to make broader reforms to alleviate the burden of property tax for more homeowners have repeatedly stalled in the Legislature over concerns about how to effectively replace the revenue. Pennsylvania students to receive free breakfast this school year.

According to Governor Josh Shapiro's office, the budget includes a \$46.5 million increase to provide universal free breakfast for 1.7 million public school students. Monson said money for the programs would not be available until the General Assembly passes fiscal code bills required to authorize the spending. Shapiro also said he had line-item vetoed \$100 million for taxpayer-funded private school tuition vouchers, which had been a sticking point for House Democrats. Federal

House FY24 Appropriations Proposal Guts Education

The Number of Students In Special Education Has Doubled In The Past 45 Years— The number of students in special education in the United States has doubled over the past four decades, creating a rising share of public school kids who need special education services. That's according to the Pew Research Center, which collected data from the National Center for Education Statistics for a report on students in special education for Disability Pride Month, which is celebrated each year in July. The total number of students in special education went from 3.6 million in the 1976-77 school year, to almost 7.3 million in 2021-22. These students now make up 15 percent of the K-12 student population across the country, nearly double what it was in the late 1970s.
