WHEREAS, Act No. 511 of the 1965 General Assembly of the Commonwealth of Pennsylvania (53
P.S. §690l et seq.), enacted December 31, 1965, and effective January 1, 1966, authorizes certain political

returns, investigations, hearings or verifications required or authorized by the taxing municipality's ordinance
or resolution, be kept confidential, except for official purposes; and
WHEREAS, any person who divulges any information which is confidential under the provisions of
any ordinance or resolution, upon conviction may be subject to fines and/or imprisonment, upon conviction,
and dismissal from office or discharge from employment; and
WHEREAS, Berkheimer requires passage of a resolution by the governing body of COUNTY specifying that said confidential
information is needed for official purposes and absolving Berkheimer from any liability in connection with
the release of said confidential information;
