Amy Eaton	Ms. Amy Eaton, a parent of a Sheffield Area student who transferred to WAHS in 2023-2024, said the transfer process was easy, but her student was not supported in transferring as a student athlete. She said there is help available now for student athletes who want to transfer from Youngsville to Warren this year due to school closing and asked why that support was not available last year to Sheffield students. She inquired if the district could appeal to PIAA on behalf of transfer students in spring sports who will, without a successful appeal, be unable to participate in post-season events.  Mr. Weber said PIAA/District 10 would not approve the academic transfers for 2023-2024 because the building wasn't closed. Even for students who were going to WAHS half time. For 2024-2025, both buildings are being closed and because it is an administrative change, we can provide a list of students to District 10 for approval.
Eddie Dorunda	Mr. Eddie Dorunda, YHS Baseball Coach, invited board members to attend YHS baseball games this season. He inquired if the extra classes will be available next year. He explained players are asking for advice on what they should do next year, and he feels he does not have answers for them.  Mr. Weber said the district can identify the areas where we know we'll have courses, specifically core. It's going to be the specials that fluctuate because those are choices. I had a lot of families reach out to me about going to Warren as opposed to Eisenhower. We designed a third process that will allow students to make that choice.
Troy McFate	Mr. Troy McFate questioned if activity busses will be provided for Youngsville and Sheffield students.  Mr. Weber said the district will be working on providing ample transportation for those students.
