# End User Agreement (Rev 5/2020)

Please scroll down and read this entire End User Agreement carefully. This is a legal agreement (the "Agreement") between you and BigTeams, LLC ("BigTeams"), which provides the terms of your use of our Products and Services (both as defined herein). BIGTEAMS provides a webbased athletic and activity management platform and various software tools and product levels allowing schools and organizations to provide content to their community (the "Product" or "Products"). BIGTEAMS also provides you access to one or more websites including: www.bigteams.com (http://www.bigteams.com); www.now.schedulestar.com (http://now.schedulestar.com); www.planeths.com (http://www.planeths.com); and/or any other website owned or operated by BIGTEAMS or its affiliates that is affiliated with the Products or any one of the foregoing websites (collectively the "Websites"). The Products and Websites are collectively referred to as the "Services".). "You" and "your" refers to the individual who wishes to use the Services. By using the Services, you are agreeing to all the terms and conditions stated in this Agreement and BigTeams' Privacy Policy. Your privacy is important. Please read our Privacy Policy to learn about our privacy practices and how we use the information we collect. If you do not agree to the terms of this Agreement or our Privacy Policy, do not use the Services.

# **Use of the Services**

You must be 13 years or older to use the Services. If you have created an account or been invited to create an account, you are responsible for all information you enter or provide. The term "Content" shall mean: (1) any information, data, text, software, code, scripts, music, sound, photos, graphics, videos, messages, tags, interactive features, or other materials that you post, upload, share, submit, or otherwise provide in any manner to or when using the Services and (2) any other materials, content, or data you provide to BigTeams or use with the Services. Any Content that you submit or upload when using the Services may be retained, accessed, used, modified, shared, or removed by BigTeams or BigTeam's customers, and their appointees, (collectively the customer and appointees are referred to herein as the "Administrator") that provided you access to the Services. You acknowledge that your BigTeams account can be managed by the Administrator that owns or controls the email address domain with which your account was created or registered, as described in our Privacy Policy.

Here at BigTeams, our goal is to help your school effectively manage and communicate athletics and activities. To do this, we need to keep the Services running smoothly, quickly, and without distraction. For this to happen, we need help from you the End User. We need you not to misuse or abuse the Services.

To describe exactly what we mean by "misuse" or "abuse" – and help us identify such transgressions, and react accordingly – we've created this End User Agreement. In accordance with this End User Agreement and the Privacy Policy, BigTeams reserves the right to remove Content that is inconsistent with the spirit or the terms of this End User Agreement and the Privacy Policy, even if it's something that is not specifically forbidden by this End User Agreement and the Privacy Policy. In other words, if you

do something that isn't listed here verbatim, but it looks or smells like something listed here, we may still remove it. Use your judgment, and let's be kind to each other so we can keep creating great things.

## Here is what BigTeams won't allow:

Disruption to the Services including:

- ✓ Interfere with or disrupt the Services, other equipment or networks connected to the Services, or disobey any requirements, procedures, policies or regulations of networks connected to the Services made known to you
- ✓ Compromising the integrity of our systems. This could include probing, scanning, or testing the vulnerability of any system or network that hosts our Services. This prohibition does not apply to security assessments expressly permitted by BigTeams

#### Wrongful activities including:

#### Inappropriate content including:

- Contains viruses, bots, worms, scripting exploits, or other similar materials
- ✓ Is intended to be inflammatory

Monitoring Activity: BigTeams is entitled to monitor and enforce your compliance with the terms of this Agreement. BigTeams may utilize the information concerning your use of the Services or Content to improve BigTeams' Products and Services and the products and services of any third party providers that we use to provide the Services or which provide Content.
