- For the second full year, the district is committed to providing a direct reading instructional program to 4th-12th grade students who require it. This has headed off legal challenges that were more prevalent when we did not have such an effective program
- Provide parents with more information on their child's academic performance via Pentamation
- Differentiated instruction
- Operating and maintenance funds targeted to fewer buildings. Less deferred maintenance
- Keep students warm, safe and dry in a clean learning environment
- Keep transportation of students to and from school in a safe, short and cost effective program.
