J. F. (Jeff) Lockett was the Chief Scientist of Sola Communications, who provided a variety of communications services and products, as well as, process, and monitoring systems. Previously, before its acquisition by Sola, he was President, Chief Executive Officer, and Chief Technical Officer of JFL Communications, Inc., an international provider of Satellite communications and manufacturer of electronic products for use in satellite communications for the oil and telecommunications industries.

Mr. Lockett's expertise includes corporate management, electronics research and development management, telecommunications and satellite system design, strategic market/technology planning, merger and acquisition evaluation and implementation, and digital, analog, and microprocessor systems design. Of note, Mr. Lockett lead the team to design and manufacture of one of the few commercial grade inertially stabilized, motion compensation antenna systems in the world today.
