7 **10500 STUDENT DISCIPLINE**

9 10510 Discipline Code

- 10
11 1. In order to provide a safe and effective learning environment the
12 District must maintain discipline in the face of student misconduct.
13 This policy is intended to provide a general outline and code for
14 the manner in which discipline will be handled. The student is
15 reminded that this Discipline Policy does not stand alone. Other
16 District policy sections also relate to student conduct including, but
17 not limited to the Student Search Policy and the Co-Curricular
18 Activities Policy.

19
20 The District acknowledges that student discipline (including
21 suspensions and expulsions) is governed by Title 22, Chapter 12 of
22 the Pennsylvania Code. It is the District's Policy that all discipline
23 (and specifically suspensions and expulsions) shall be administered
24 in accordance with Title 22, Chapter 12 of the Pennsylvania Code,
25 which is incorporated herein by reference.

26
27 2. **SCOPE OF THIS DISCIPLINE CODE**

28 This code will govern any circumstance or action that has impact
29 upon the District, its employees or students, or the educational
30 process of the District. That means this code will govern behavior
31 and circumstances that occur during school or school related
32 activities, on District property, and during a student's transit to or
33 from school. Additionally, this policy may apply outside of school
34 property or school related activities if there is misconduct that has
35 a direct and immediate tendency to influence the conduct of other
36 people while in the school room, to set at naught the proper
37 discipline of the school, or to impair the authority of the District's
38 employees. (Examples of this would be insubordination to a
39 teacher at a restaurant or intentional infliction of damage to a
40 teacher's house.)

41
42 This code gives a general description as to consequences that the
43 District will impose through its system of discipline. The student
44 should be aware that in addition to the consequences of this code
45 the student may also be subject to criminal prosecution for
46 misconduct that rises to the criminal level.
47

3. HOW TO UNDERSTAND THIS CODE

Described in the paragraphs below are general categories of misconduct. For the most part these categories are described in one or two words; the categories are intended to be very general in nature and broad in their scope. When a student is disciplined for misconduct the consequence of the misconduct will usually be the consequence(s) set forth in numerical order under the applicable general category. When more than one category applies the District may impose discipline under the category or categories it believes most applicable.

The discipline outline herein will be carried out in accordance with the laws of Pennsylvania. However, this code cannot anticipate every possible circumstance or type of misconduct. Therefore, this code is intended to serve as a general guide applicable to most, but not all situations. Greater or lesser discipline, alternative referrals or other alternatives or action not necessarily set forth herein may be taken or imposed depending upon the circumstance of the infraction.

The student must be aware that the District cannot police every instance of misconduct. Because the District does not impose discipline upon a student for misconduct is no reason to believe that the District will not impose discipline for the same misconduct the next time it occurs. When two or more students are involved in misconduct the fact that the District does not impose discipline upon one of those students is no reason to believe that the District will not impose discipline upon the other student(s).

In addition to the discipline described below, the student is advised that the District may also confiscate any items used in association with misconduct (such as tobacco, cheat sheets, weapons, diskettes, beepers, telephone, alcohol, etc.). **The student is also advised that student misconduct will also result in police notification if, at the District's discretion, the misconduct rises to the level of criminal behavior or if police notification is required by law.**

From time to time the consequences listed below include the phrase "or other disciplinary action." That phrase is intended to include suspension, expulsion or referral to the hearing officer. Other disciplinary measures ~~such as detention~~ **including but not necessarily limited to detention, community service, restitution, educational project, letters of apology, and/or referrals for counseling or to a Student Assistance Program (SAP)** may be

substituted for and/or added to the consequences described below at the discretion of the building Administrator.

Special education students will be disciplined under this policy subject to the requirements of State and Federal guidelines.

4. MISCONDUCT GOVERNED BY THIS POLICY

A. ASSIGNMENT CUTS

Category I

Refusal to comply with a directive given by an employee of the District, when such refusal does not create a substantial disruption to the school environment or degrade a District employee. Examples may include but are not limited to sleeping in class, not sitting down when asked, and refusing to do work.

Any act of disrespect by a student towards a District
employee or an affiliate of the District, or towards any such
person's property which occurs at any time and which is
linked to that individual's association with the District will
be subject to disciplinary action according to this
subsection.

C. DISRUPTIVE BEHAVIOR

LOCKER)**

E. ALCOHOL AND DRUGS

Students are prohibited from using, being under the influence of, possessing or transporting, or dispensing (by sale or gift) any of the following at any school or school related activity, or while in transit to and from school or school related activity, or in any way that directly impacts the discipline or authority of the school:

1. Alcoholic or Malt Beverage
2. Any substance regarded as controlled or illegal under the laws of the Commonwealth of Pennsylvania.
3. Any look alike substance intended to mimic any substance described in the preceding sentence.
4. Any mechanical device (such as pot pipe, syringe or needle) capable of utilization for taking any substance regarded as controlled or illegal.
5. Any other medication. **For purposes of this section, the term “medication” shall include all prescription and non-prescription/over-the-counter medications.** ~~(prescription or non-prescription) possessed or used without parents or guardians consent.~~
6. Any other substance capable of causing or taken for the purpose of achieving a "high" or other altered state.

~~Additionally students who, with their parents or guardians consent are in proper possession of non-prescription or prescription medications for a legitimate health concern are prohibited from dispensing that non-prescription or prescription medication to any other student or person at any school or school related activity, or while in transit to and from school, or in any way that directly impacts the discipline or authority of the school.~~

~~Students in proper possession of prescription or non-prescription medication must, at the earliest opportunity, advise the building Administrator or nurse (or in the case of a co-curricular event, the Administrator or employee in charge) of the medication and must follow the instructions of the Administrator/nurse/employee with regard to the possession/care of that medication.~~

Nothing in this section is intended to discipline or punish any student who is in proper possession of or who properly utilizes medication or a mechanical device in accordance with the District’s “Administration of Medications” policy.

Any violation of this section will result in notification of parents or guardians. For any violation of this section concerning usage, being under the influence, possession or transportation of alcohol or drugs (as defined in items 1 through 6 listed above), a student will be subject to the following discipline: ~~receive a three to ten day suspension and be referred to the hearing officer for further discipline including expulsion from school as the most likely consequence.~~

.....#1 Offense – Suspension for 3 to 10 school days and referral to the hearing officer for further discipline including expulsion from school as the most likely consequence; required parental conference; and referral to Student Assistance Program. Less severe discipline may be imposed depending on the type and/or quantity of drugs or alcohol that the student uses, possesses, transports, or is under the influence of.

.....#2 Offense – Suspension for 10 school days; referral to the hearing officer for further discipline, including expulsion from school as the most likely consequence. A parent conference will also be required and intervention/assistance will be provided through either a referral to a school-designated drug counselor or a referral to an appropriate drug and alcohol program.

For any violation of this section concerning dispensing of alcohol or drugs (as defined in items 1 through 6 listed above), a student will receive a three to ten day suspension and be referred to the hearing officer for further discipline including expulsion from school for a period of not less than one year as the most likely consequence. A parent conference is required. Help will be provided through the mandated appointment(s) with a school designated drug counselor or referral to an appropriate drug and alcohol program.

If a student is expelled for a drug and alcohol violation, the Board shall require, prior to readmission, that the student provide sufficient evidence (to the District’s satisfaction) that the student has received appropriate intervention/assistance relative to the drug and/or alcohol violation.

7 1) Weapon defined: "Weapon" for the purpose of this policy "shall
8 include, but not be limited to, any knife, cutting instrument,
9 cutting tool, nunchaku, firearm, rifle or any other tool,
10 instrument, or implement capable of inflicting personal bodily
11 injury." *

12

13 2) Discipline defined – **For any violation of this section, a student**
14 **may be suspended and will be referred to the hearing officer**
15 **for further discipline in accordance with Act 26 of 2005.** The
16 District "shall expel, for a period of not less than one year, any
17 student who is determined to have brought a weapon onto, is in
18 possession of, or uses a weapon on any school property, any
19 school sponsored activity or any public conveyance providing
20 transportation to a school or school sponsored activity." **The**
21 **Superintendent may recommend modifications of such**
22 **expulsion requirement on a case-by-case basis. Any violation**
23 **of the District’s weapons policy shall also result in a required**
24 **parental conference and a required referral to the Student**
25 **Assistance Program.** *

26

27 3) The provisions of this policy "shall not apply to the following:
28 a. A weapon being used as a part of a program by a school
29 or by an individual who is participating in the program;
30 or
31 b. A weapon that is unloaded and is possessed by an
32 individual while traversing school property for the
33 purpose of obtaining access to public or private lands
34 used for lawful hunting, if the entry on school premises is
35 authorized by school authorities."

36

37 4) *Procedure: All provisions of Act 26 of 1995 will be
38 applicable in the administration of this policy.

43 Bullying defined: an intentional electronic, written, verbal, or

44 physical act or series of acts directed at another student or students

45 that is severe, persistent, or pervasive and has the effect of doing any

46 of the following:

- 1 1. Causing substantial interference with a student’s
- 2 education;
- 3 2. Creating a threatening environment;
- 4 3. Causing substantial disruption of the orderly operation of
- 5 the school.

6

7 Bullying, as defined in this policy, includes cyber-bullying.

8

9 The Board prohibits all forms of bullying by district students.

10

11 Students who have been bullied should promptly report such

12 incidents to the building principal.

13

14 The Board directs that complaints of bullying shall be investigated

15 promptly, and corrective action shall be taken when allegations are

16 verified. Confidentiality of all parties shall be maintained, consistent

17 with the district’s legal and investigative obligations. No reprisals or

18 retaliation shall occur as a result of good faith reports of bullying.

19

20 The Superintendent or designee shall ensure that this policy is

21 reviewed annually with students.

22

23 This policy shall be accessible in every classroom. The policy shall

24 be posted in a prominent location within each school building and on

25 the district web site, if available.

25 O. BEHAVIOR ON SCHOOL TRANSPORTATION (MINOR
26 OFFENSE)
27

28 Students must sit in assigned seats facing forward; student must
29 follow driver's instruction and must refrain from pushing, hitting,
30 creating unreasonable noise or distractions, opening windows against
31 the driver's orders, placing hands or body out of window, harassment
32 of persons outside the vehicle or similar offenses that pose a hazard to
33 the safety/welfare of other students, the driver, or persons outside the
34 vehicle.

- 35First Offense - Warning and parent will be notified
36Second Offense - One day suspension of riding privileges
37Third Offense - Three day suspension of riding privileges
38Fourth Offense - Fifteen day suspension of riding privileges

44 P. BEHAVIOR ON SCHOOL TRANSPORTATION (MAJOR
45 OFFENSE)
46

1 Students shall refrain from fighting, damaging the vehicle, throwing
2 objects out windows, opening any exit doors or similar offenses that
3 pose the threat of serious danger to the safety and welfare of students,
4 the driver or persons outside of the vehicle.

5
6First Offense - Suspension of riding privileges for 3 to 30
7 days.

8Second Offense - Suspension of riding privileges for a
9 minimum 30 days. (A review of the case will take place after
10 10 school days and will include a meeting with the building
11 Administrator, parents, and driver.)**

12Third Offense - Suspension of riding privileges for the
13 remainder of the school year. (A review of the case will take
14 place after 30 school days and will include a meeting with the
15 building Administrator, parents, and driver.)**

16
17 Students will be held responsible for damages to any school bus.

18
19 **The review meeting will be an opportunity for student, parents,
20 driver, and the building Administrator to discuss the suspension. If
21 the review reveals that the student/parents have developed an
22 understanding of acceptable behavior, reinstatement of bus riding
23 privileges could result. It will be the responsibility of the parent to
24 contact their child's building Administrator to schedule the review
25 meeting.

26
27 **Q. MISCELLANEOUS INAPPROPRIATE BEHAVIOR**

28
29 Any student who engages in inappropriate behavior, not otherwise
30 specifically addressed in this code, including but not limited to self-
31 destructive behavior, behavior that may be harmful to others or the
32 property of others, or other behavior which negatively reflects the
33 values of this discipline code or the philosophy, goals and aims of the
34 District, will be subject to suspension or other disciplinary action.
35 The discipline may include action by the building Administrator as
36 well as a possible referral to the hearing officer for further discipline.

37
38 **R. TRANSFER STUDENT, SUSPENDED, EXPELLED, IN**
39 **ALTERNATIVE EDUCATION OR OTHERWISE UNDER**
40 **DISCIPLINE FROM ANOTHER SCHOOL DISTRICT**

41
42 Students transferring into the District who are under discipline from
43 their previous school district or were in a discipline based alternative
44 program in their previous district will be placed in the District's
45 Alternative Education Program or will be otherwise disciplined in the
46 manner utilized by the District that most closely approximates the

1 discipline imposed by the previous district. The decision for
2 placement/discipline will initially be made by the building
3 Administrator. Students who wish to appeal this placement/discipline
4 can have their case heard by the District's hearing officer by written
5 request which must be submitted to the District within 7 calendar
6 days of the building Administrator's placement/discipline decision.
7

8 Students transferring into the District who are pending adjudication in
9 their previous school district are required to notify the District of the
10 adjudication result via a copy of the official adjudication report; based
11 upon that report, the District will implement placement/discipline as
12 set forth above.
13

14 S. CAUSING, ATTEMPTING TO CAUSE, THREATENING , OR
15 PLANNING A MAJOR DISRUPTION
16

17 It is a violation of this Code to participate in, attempt, threaten, or plan
18 any act which leads to, or has the reasonable potential of leading to, a
19 major disruption of the school routine by interrupting school or a
20 school-related activity, or by placing groups of students or school
21 personnel in danger or distress. Examples may include but are not
22 limited to setting off, attempting to set off, threatening to set off, or
23 planning to set off a fire alarm; making, attempting to make,
24 threatening to make, or planning a bomb threat; setting fire, attempting
25 to set fire, threatening to set fire, or planning to set fire to a building;
26 and participating in , attempting, threatening, or planning any event
27 that leads, or has the reasonable potential of leading to, the evacuation
28 of a school building.
29

30 Any violation of this Section will result in a three (3) to ten (10) day
31 suspension. The student will be referred to the Hearing Officer for
32 further discipline, including (i) expulsion from school as the most
33 likely consequence in the event that a major disruption is attempted,
34 planned, or threatened, but not actually caused or (ii) expulsion from
35 school for a period of not less than one year as the most likely
36 consequence in the event that a major disruption is actually caused. In
37 considering whether an expulsion will be imposed, and, if so, the
38 length, the Hearing Officer is to consider, among other factors deemed
39 relevant by the Hearing Officer, the age of the student, the forethought,
40 and the actual disruption to the school environment.
41

42 T. INVASION OF PRIVACY
43

44 Students should refrain from unreasonable intrusions concerning the
45 privacy of District employees, other students or third parties.
46 Invasions of privacy can include (but are not limited to) casting

1 another in a false light, creating unwarranted publicity about another,
2 obtaining information about or images of another via inappropriate
3 means, or tampering with information concerning another.
