**Course Description:** Designed to prepare students for post-secondary career opportunities, students will focus on language arts skills essential for job placement as well as success beyond the classroom. Great themes and issues found in literature will be examined to serve as a final arts and humanities experience. Students will establish a mastery of language conventions and mechanics. With a focus on career readiness, the class will aid students in developing a command of general, academic, and domain-specific vocabulary. Through various discussions and a required formal speech, students will be proficient public speakers.
