Course Description: Reading 11 is a blended learning intervention program building reading comprehension and fluency, academic earning, and writing skills for struggling students. This course utilizes a flexible rotation designed to help eachers address students at all levels of intervention. This model for Blended Learning consists of Whole-Group Learning and station rotations between Student Application, Small-Group Learning, and Independent Reading.

- 3) Organization: Create organization that logically sequences claim(s), counterclaims, reasons, and evidence; use words, phrases, and clauses as well as varied syntax to link the major sections of the text to create cohesion and clarify the relationships between claim(s) and reasons, between reasons and evidence, and between claim(s) and counterclaims; provide a concluding statement or section that follows from and supports the argument presented.   - Use various types of phrases and clauses to convey meaning and add variety and interest.
  - Use precise language, domain specific vocabulary, and techniques such as metaphor, simile, and analogy to manage the complexity of the topic.
- 5) Conventions: Demonstrate a grade-appropriate command of the conventions of standard English grammar, usage, capitalization, punctuation, and spelling.
