Course Description:

Reading 11 is a blended learning intervention program building reading comprehension and fluency, academic learning, and writing skills for struggling students. This course utilizes a flexible rotation designed to help teachers address students at all levels of intervention. This model for Blended Learning consists of Whole-Group Learning and station rotations between Student Application, Small-Group Learning, and Independent Reading.

- 3) Organization: Create organization that logically sequences claim(s), counterclaims, reasons, and evidence; use words, phrases, and clauses as well as varied syntax to link the major sections of the text to create cohesion and clarify the relationships between claim(s) and reasons, between reasons and evidence, and between claim(s) and counterclaims; provide a concluding statement or section that follows from and supports the argument presented.
