I wanted to be involved in my community as I had raised my own children through high school. Although I didn't get on the ballot in time, when I noticed there was a School Board opening in my area. I didn't let that stop me. I wanted to have a voice for the children and parents of my community and I made a lot of effort toward that goal.

What qualifications or strengths would you bring to the position? _____

I am a life-long resident of Warren County. I graduated from Eisenhower High School and pursued higher education at the University of Pittsburgh at Bradford. There I earned a BA in Human Relations and graduated with honors. I have experience in homeschooling, private and public schooling, and cyberschooling. I volunteered my time as a Guidance Counselor at a local private school. I was a substitute with the WCSD and a staff member at the 21st Century afterschool program. I am an adjunct facilitator in the education department of the Women's Care Center of Warren. I am also employed part time as a floating elementary teacher at a private school.

List school or community organizations/activities in which you have been involved: _____

I am a regular church attendee and have always been involved with music there. I have been a performer at the Warren Festival of the Arts. I am the lead singer and keyboardist of the Jammers. We perform pieces from the 40s to the 60s at nursing and personal care homes. I have been supportive and involved with every athletic team my children were involved with. I started an Impact Bible Club at Sheffield High School. My work at the Women's Care Center brings me into 9th grade Health classes across the county with the message of positive relationships and healthy choices.

Please provide any additional information you feel would assist in evaluating this application: _____

I started my write in campaign in April 2021 to earn a seat from Region 2 to the School Board as soon as I was aware the position was open. I worked hard, gathered momentum and support. I spent a considerable amount of time and effort to achieve my goal. My two week old campaign at the primaries garnered me nearly 150 votes. I campaigned at meetings and the Warren County Fair. I have a whole team of people guiding me and supporting me. I have nearly 90 members on my Facebook election page. I was heavily canvassing Region 2 when I was struck with Covid in early October and unable to finish working my campaign up to the election. Those who supported me took up the mantle and kept going on my behalf. Even with all that was against me and the sickness that hit this area at election time, I was still able to earn over 700 votes. There were many more outside of Region 2 who had also wanted to vote for me. I believe I am the most qualified and supported applicant for this position and I ask you to elect me to the open seat.
